ORDERS HALT IN SALE OF LOCKER CLUBS TO MINORS

Chief of Police Beavers announced a war on all of the locker clubs of the city Friday which are selling liquor to boys and girls under age or are in any way violating the locker club regulations. The order is especially directed to keep young girls out of the locker clubs.

Chief Beavers' action followed instructions from the Grand Jury Friday morning ordering the police department to clean the city of all its viceroy, (lockers and other places of evil repute. It was the sentiment of the Grand Jury that the presence of a constant menace to the welfare of the city and very probably was largely to blame for the wave of crime which has swept Atlanta in the last few weeks.

The Chief made it plain that the police would continue their campaign against the clubs until the viceroy of the city is cleaned up. He said that he had received scores of complaints which related that boys and girls under age had been seen intoxicated in many of the clubs of the city. Here in the Chief's order as it was issued to every policeman on the force:

Illegal Sales Must Stop.
The officers and members of the force are instructed to keep a close watch on the locker clubs in the city where there is reason to suspect that boys and girls are allowed to consume and drink intoxicants illegally, and make cases when sufficient evidence can be obtained.

"This illegal sale of liquor must stop," said the Chief in discussing his order.

Draught Action Needed.
The sale of liquor to persons not members of the clubs is bad enough, but when it comes to selling girls, it is hardly out of short dress, it has reached a stage when I feel that the most drastic action is warranted by my department.

I have told the policemen that when they see young girls going into the clubs that it is sufficient warrant for them to go inside and make an investigation. There is to be no tolerance and no handling of the situation with gloves. We are simply determined to wipe out this practice, which probably is leading scores of girls yearly into immoral lives, and we are going about it at once with any more warning to those who are engaged in the business.

"The locker clubs must obey the law to the very letter. If they do not, their cases will be called to the attention of the police committee, and the permit most likely will be revoked."

CHIEF PLANS TO CRUSH ROBBER BANDS

Chief Beavers made a personal plea to members of the day watch to arrest every person who does not give a satisfactory account of himself, and to force all suspects to prove they have a means of livelihood other than hanging around pool rooms and street corners.

Wants Them All Arrested
"Beginning Friday morning," said Chief to the policemen, "I want every loafer and vagrant in Atlanta arrested. Every man must keep a close watch and pick up all suspicious characters."

"Go into the pool rooms and the saloons, and if you see loafers there, arrest them. If they claim they work, take their names and addresses and investigate. If you find they are lying, lock them up."

"We must drive out this element that feeds crime and vice," said Chief Beavers, "and we must do it by force."

Detectives Get Orders, Too
Chief Beavers announced that he will issue his personal orders to the evening and morning watches, and impress upon them the necessity for increased vigilance to rid the city of the gangs of criminals that have flocked here within the last week or ten days.

The detective have been given orders similar to those issued to the policemen, and Chief Beavers says he will crowd the city jail with loafers and vagrants if necessary to stop the epidemic of crime.

To testify to the fact that we are a united people and no longer a number of segregated sections, we should make our definite contribution to all national festivals or occasions. This does not debar us from the propriety of commemorating local celebrities or in making of memorial days which mean so much to the lives of history and precedent to the lives of the present generation of Southern men and women.

To observe the Fourth of July, therefore, with dignity and importance is a part of every loyal American's duty. If he values the independence of foreign control and the liberty guaranteed to American citizens.

The populace always will have modes of its own, such as the firing of salutes, the waving of flags, processions with music, which are in themselves respectable, but there is a war and danger method of observing the day which is to be commended to younger and old alike.

First, Christianity has played an enormous part in the organization and maintenance of all that is good in this Republic. Hence, it is eminently consistent and proper that, without any formal proclamation of President or Governor, Christian people should assemble in their places of worship for united acts of praise for Divine protection and prayers for a continuation of His guidance to harmonize co-operation among ourselves and for the spirit of unity and comity with other nations. A natural feeling of all celebrations, public or private, would be the reading of the Declaration of Independence.

Frank, owner of 77 Pratt Street, negro maid at the Fourny home, said that she actually answered the telephone on the night of April 16. Frank had called half a dozen times the night of April 16 and 18:00 o'clock in the evening.

She said she had been approached many times by detectives who sought to persuade her to corroborate the affidavit of Mrs. Fourny. She added that she had told them she was not true.

Men Drive Woman's Story.

Another witness, a man in the crowd at the time, told a Georgia reporter that he was at the house the night of April 16, and that he is positive that Frank did not call up. Mrs. Fourny said in her affidavit that they were playing bridge when the telephone rang. This witness declared they did not play bridge during the whole evening, and that the telephone call that the whole story of Mrs. Fourny is a fabrication.

Still another witness is a friend of the housekeeper at the Fourny residence. He recalls the circumstances exactly as the other man who was there that evening.
