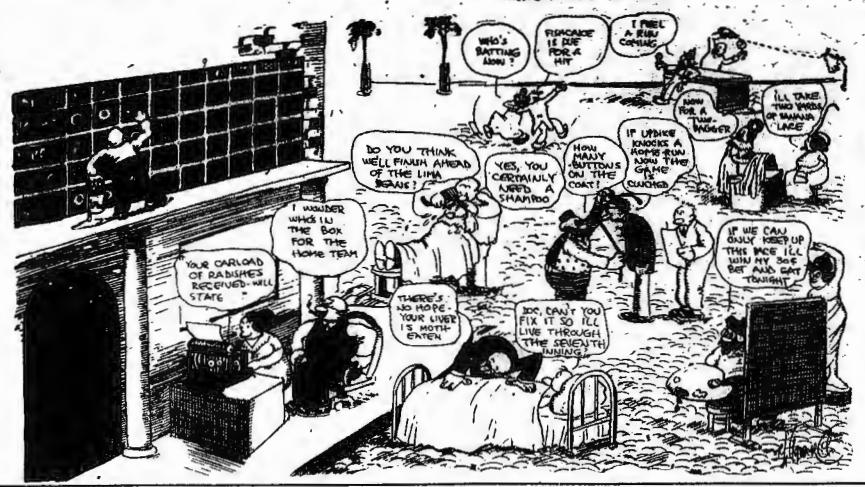

Another jury has "no blotted" their names before they would be called. A grand jury is composed of not more than twenty-three men, but less than eighteen members. Practically always a grand jury case allows the jury members to remain away from sessions if they so desire and still perform their function. Twelve of the eighteen grand jurors, who must be present, must vote. In favor of an indictment before a "trial bill" can be returned. The indictment requires twelve votes (rather eighteen or twenty-three jurors are present when it is considered). While it is not customary, if the grand jurors themselves so desire, they can have a defendant before it if the witness in the case or statement, or they can hear the testimony of any witness for the defense or issue in the proceedings of any attorney for the defense. As a rule, however, the grand jury members consider the state's case and leave it to a superior court jury to decide when the evidence is introduced by the defense is stronger than that of the state.
