

"NO QUARTER" CRY IN SHIPPING FIGHT

Battle Over Bill to Buy Vessels Resumed in Senate—Democratic Leaders Resolved to Overcome the G. O. P. Opposition.

Washington, January 31.—The legislative struggle in the senate over the government ship-purchase bill, which seems destined to take historic place in the history of commerce, will be resumed at 10 o'clock tomorrow morning when the senate reconvenes after a recess since Saturday midnight.

When democratic leaders consented Saturday to a recess at midnight, representatives of the administration were sure that it was a sign of weakening, but the administration general hastened to the floor to renew the fight with more vigor than ever. The opposition would be shown that the majority could talk eight and day until the bill is put on its passage. They are confident that three or four more days of continuous session will force a roll call on the

question, which is the whole bill as amended in caucus, and that thereafter the measure will move quickly through remaining senatorial stages.

G. O. P. Leaders Confident.

Republican leaders are just as confident as the democrats that the bill will be passed, and that it will be voted on Saturday.

Senator William Alden Smith, who talked for more than five hours Saturday night, will read the speech of the bill itself, and resume his address tomorrow. Senator Jones of Washington, plans to follow him in his speech, and for the first time speaking. Some of his associates said he might hold the floor for twenty-four hours.

"We propose to keep the bill before the senate from now on," was Major Smith's speech yesterday.

"And we are ready for any campaign the democratic may inaugurate," asserted Senator Wallinger, the minority leader.

Many republicans have long been in preparation. Others have had the fight for the minority thus far been planning to talk again. Not until Saturday night, however, did the opposition, however, democratic, say their parliamentary advantage at this time of the struggle soon will be

present, and that a day will be found to break the deadlock.

Immigration Bill Veto.

What is the fate of the president's veto of the immigration bill is a subject of great interest in Congress for the week. The veto message was read in the house yesterday by the entire day and much of the night will be devoted to its discussion.

It is to be voted on Saturday, at which it originally was passed and to pass over the executive disapproval.

The bill, which required a two-thirds' majority vote can be passed if it passes fast doubtless. It is to be voted on Saturday, probably more than the necessary two-thirds, it having passed three "originals."

Senator Reed, who has opposed the administration in much of the party work, has written a note to his colleagues to support the president's veto of the immigration bill in a senate speech, and will speak on the floor during the ship-purchase debate.

National Measure in House.

The naval appropriation bill contains the usual budget figures, and deals with the fight of the building program pending. Debate will be resumed Tuesday, and an effort will be made to pass the bill on Saturday night.

The fortifications subcommittee on appropriations will meet to complete the bill, and will then go to the floor during the ship-purchase debate.
