The sheet will immediately be sent to the mayor for his veto, it is still indicated that he will veto it, but such action on his part is not absolutely certain.

the aldermanic board, and he explained that he intended to bring to the doubtful members that they are taking a chance. He explained that he has agreed to show that the anticipated revenue from various sources will fall below the amounts estimated.

URGES THE ENROLLMENT OF ALL SCHOOL CHILDREN

State Superintendent Sends Out Circular Letter to All County Superintendents.

M. L. Brittain, state superintendent

of public education, has sent out a circular

letter to all county superintendents

in the state urging upon them

the necessity of emphasizing the

enrollment of all children upon the school

rosters.

With each letter he gives the figures

for 1914 of the number of children in

the county to which the letter is directed

who did not attend school a

single day for that year.

In his letter he declares "we shall

never succeed in educating the children

who are not in our schools and in the

absence of a compulsory law if the

county authorities do not emphasize

the enrollment of all children in the

district the number of illiterates

will not be diminished."

Superintendent Brittain, however,

thinks the question of diminishing the

illiterates is not a hopeless task. The

figures recently issued by the federal

bureau of education show that in Georgia

the number of illiterate children

per 1,000 in 1914 was 57, as against

109 in 1907.

The county superintendents largely

are offering Superintendent Brittain

considerable co-operation.

He has just received a letter from

W. B. Morris, county superintendent at

Hartwell, Ga., telling of his plans for

initiating a plan, February 5, when he

hopes to do much toward having the

teachers that all children are enrolled.

Mr. Brittain has in his office the stub

of a personal check which he values very highly. This represents a prize that he offered personally for the teacher who would do the best work in reducing illiteracy among adults. This prize was won by Miss A. Brooks in Hartwell county. So successful was she that when there was about to be a change and she was to go elsewhere the people of Hartwell would not stand for it, and she had to stay there.

In Hungary there have been bread riots and much suffering from hunger. While Austro-Hungary is bound not to sign peace until Germany does so, it may be that revolution at home will force the hands of statesmen.

The commissary is going to play almost as vital a role in this great war as numbers, strategy and cannon. And the commissary applies to the people at home as well as to the men distant on the firing line.

A NATIONAL SCANDAL.

The veterans of the civil war are dying at the rate of 15,000 a year. One hundred pass away every day. We are spending more for pensions now than we ever have spent before.

That is the arraignment brought against the democratic party in the current issue of "World's Work," an editorial extract from which is reproduced elsewhere on this page. Our contemporary proceeds to say that it was bad enough when one republican administration after another shamelessly jammed through indefensible blanket and private pension measures. There was, it says, some hope for relief when the democratic party came into power. But the democrats have almost unlocked the treasury doors and thrown the key away. Certainly, their pension extravaganzas have made those of the republicans look pale by comparison.

And the republican party, in its palmy and most generous days, never produced a Sherman, whose pension proposals have shocked even the G. A. R.

No one objects to legitimate pensions within legitimate bounds, but the people revolt at the plunder now characterizing pension legislation. The attitude of the democratic party in this respect is particularly indefensible. Traditionally the champion of economy, it seems to have formed a co-partnership with pension and political graft of the worst type.

Speaking of war taxes! If the rivers and harbors bill were abandoned for a year and the pension expenditures placed within reasonable figures, there would be no need of a war tax. Evidence accumulates that the country wastes of pork bill extravaganzas and pension frauds.

The party is coming in for an accounting, if it persists upon its present course with regard to pensions.

PLUCKING THE PLUCKERS.

Majority Leader Underwood has rendered a genuine service to the country in leading the fight which has induced the house to abolish the "plucking board" in the navy department. Concurrence by the senate and signature by the president will put an end to a practice that is dangerous, un-American, unjust and subversive to the best interests of the naval establishment.

By the operations of the plucking board, always conducted in secret, any naval officer, irrespective of rank, distinction, service, age or fitness, could be summarily retired without reason or redress. The injustice worked by this condition, and the loss to the country, would be difficult to estimate.

Men who were perfectly fit, physically, mentally and otherwise, have been retired without warning to make way in the line for some favorite with political or other pull. The result is that there has been produced a large contingent of dissatisfied officers, men who had not wanted to retire, who were full of ambition for promotion and for service. RAILROADS GAINING, WILSON IS INFORMED

Chief of Lehigh Valley Tells President Business Conditions Steadily Improve.

Washington, February 3.—President Thomas, of the Lehigh Valley Railroad, told President Wilson today business conditions showed improvement and that the roads were gaining from an increase in traffic. They needed less regulation, he told the president, to better their condition.

"When I say that the railroad with which I am connected made 25,000 reports last year to the interstate commerce commission and different commissions and boards in the three states through which it runs, you will see what I mean by the need for less regulation," Mr. Thomas said. "We need constructive legislation."

An amendment to the commerce clause of the Hepburn law introduced in the house by Representative Adamson, prohibiting railroads from owning stock in coal companies, was mentioned by Mr. Thomas to President Wilson as being in pending measure which would greatly hurt some roads. The measure was recommended by Attorney General Clegg.

Mr. Thomas said his road and several others had plans for extensions and improvements, but were waiting to get money. The increased freight rates granted by the interstate commerce commission, he added, were somewhat, he said, but other assistance from federal and state governments was needed.

The Holtzendorfs ordered the boys to whip him, it is said, but in the fight which ensued the teacher again got the best of it, and the father joined the boys.

The teacher, who had expected trouble, had armed himself and shot the older son, inflicting a serious wound. Wilbur Holtzendorf, the older son, then shot the teacher, it is claimed, inflicting a wound which caused his death.

The killing caused a tremendous sensation and much feeling in the community. Mr. Yates came from West Florida and was a young school teacher of high character, the son of a prominent turnpike operator. Wilbur Holtzendorf was landed in jail at Jasper.
