WASHINGTON, June 3.—The special committee on the "lobby" which is investigating the means by which legislation is secured in the Senate, today announced that it had failed to find any "insidious" lobby. The committee, which is headed by Senator Charles McNary, today reported that it had held a hearing on the first day of its inquiry and that no evidence had been shown that any improper means had been used to secure legislation. The committee is expected to continue its inquiry throughout the week.
