To furnish to its members industrial information affecting the various branches of trade in which individual members are interested, and to maintain the interests of the manufacturer and incidentally promoting the welfare of their personal acquaintances, promote confidence and be of mutual benefit.

**OKLAHOMA STATE BANKS MUST PAY ASSESSMENTS**

OKLAHOMA CITY, Okla., Jan. 6.—More than \$400,000 of the state of Oklahoma's emergency fund was held to be a just debt by the state supreme court, which held that the state must mean the debt is collectible from more than 100 state banks, which have been assessed by the state association to the fund by nationalization legislation prior to 1912. The court held such action did not violate the state's ability to guarantee funds borrowed while they operated under the state laws.

REVENUE FOR IMPROVING DEFENSES NOT IN SIGHT.

Congress Leaders Agree Extensive Additions Cannot Be Made This Year

WASHINGTON, Jan. 5.—Chief results of last night's conference between Secretaries Daniels and Garfield and congressional leaders were the general conclusion that the government's revenue for the coming year would not bear any heavy burden on the defense establishment, but that next year, when congress considers some means of raising revenue, it should consider a general stamp tax which then expire, the subject of appropriations for national defense.

The outlook for a prolonged European war will be considered in connection with revenue plans.

The financial committee unanimously adopted today the provision in the naval bill for a strategic bureau to be established, and the committee responsible to the secretary of the navy said to have full supervision over all present naval activities.

It also approved the provision for \$1,000,000 for aviation.

Those voting in the conference included Secretaries Daniels and Daniels, Senators Chamberlain and Tillman, chairman respectively, of the Senate military and naval affairs committee; Representatives Hayes and Padgett, chairman, respectively, of the House military and naval affairs committee; Representative Shadley, chairman of the house subcommittee on foreign affairs appropriations, and Representative Radcliffe, chairman, majority leader of the house.

Under the influence of the drug he explained his attempt at suicide by saying he hasn't a friend or relative in the United States.

Evidently he was a recent arrival in Atlanta, and by his side in the Terminal waiting room were found a man and a woman whose names he refused to give.


