## SNOW STORM HALTS WORK OF RESCUE IN EARTHQUAKE'S PATH

Americans Enlist to Aid Italian Soldiers in Searching Ruins for Dead and Injured and Caring for Survivors

## DEATH TOLL GROWING WITH SEARCH OF RUINS

One Estimate Places Dead and Injured at 100,000—Switzerland Shaken by Quake Causing Avalanches

(By Associated Press) **ROME, Jan. 15.**—A heavy fall of snow this morning hindered the rescue work in Italy, but the death toll was not increased. The new estimate of deaths is now 100,000. The death toll and property damage are appalling. Estimates of the number of dead vary from 50,000 to 100,000, while estimates of the total number of dead, dying and injured vary between 50,000 and 100,000. It will probably be days before the exact figures are available.

Americans are today aiding the Italian Red Cross in its reconstruction. Ambassador Thomas Nelson Page is at the ministry of the interior, representing and after expressing American sympathy, has come to the rescue of Italy's attachés with motor cars to the scene of the disaster.

The Italian Red Cross approaches that which befell Messina six years ago. Azzano, sixty miles east of Rome, was the most affected, so far as loss of life was concerned. But about 100 towns and villages, all affected, are in a condition similar to that of Messina.

### SWITZERLAND HIT, TOO.

Report today says the shock was felt as far as the Swiss frontier and that in the Alps in that region there were many avalanches. The Swiss are making it appear that the earthquake extended throughout the entire length of Italy, with the exception of the extreme southern end.

The Italian government and people have moved quickly to help the stricken people.

Through the Red Cross, the government sent to the Swiss frontier and the work of rescue and relief is proceeding night and day. The Italian Red Cross and its attachés and medicines have been dispatched by train where possible, and by motor car where roads are available.

The Red Cross central committee was quick to act, having engaged all of its members to help in the relief work.

The Italian Red Cross sent a telegram to the government, which is to be forwarded to the king, asking that medical and medical supplies be sent to the stricken areas.

Alone, Hungry and Unable to Work, Mrs. Cassie Henley, 691 Fair Street, Ends Earthly Sorrows

She left without son or daughter or husband. She was a widow.

The workers with whom she had lived for two months—a live coal oil lamp, a red hand, a bottle of poison.

It was torture to touch with it. She could not bear it.

She had the heart hank and waited.

The neighbors were kind; they helped until her head was bowed with pain.

The little memento she had left.

The days her hand was well dribbled away. Friday morning she had 15 cents.

**POLICEMEN OPEN FIRE ON OPERA LOVERS SUBSCRIBE  
NEGRO IN HEART OF CITY TO FUND FOR GUARANTEE**

Break Big Windows and Narrowly Miss Hitting Night Watchman

Considerable excitement was created along Broad and Alabama streets, in the central portion of the city, shortly after 11 o'clock Tuesday night, when a policeman and two street car men chased and fired several pistol shots at a negro who had attacked a street car conductor with an ugly-looking club.

When a West Fair street and Druid hills car reached Broad and Marietta street Robert Howard, a negro, on the street, was shot. He was hit in the abdomen, the negro said, but he was not in the presence of liquor or drugs, drew from his pocket a long dirk and lunged several times at Conductor H. C. Hall.

The conductor escaped injury by the wild lunging of the negro, who continued his attack until the conductor began to use his pistol, whereupon the black jumped from the car and ran with other negroes, who were pursued by Conductor Hall and the motorman of the car.

The conductor attempted to stop the men as he dashed across Broad street bridge and fired at them when he returned to Hall. On Alabama street, the negro, who was shot, ran toward Whitehall street crossing the right was bloodied by Traffic Officer W. H. Williams, who had been on the street at this point still clutching the dirk in his hand.

At the time of the shooting, where the negro was taken, it was found that he had two slight flesh wounds in the right arm, which were carried to police headquarters. He will be tried before Recorder Johnson.

Large windows at 1 and 4 North Broad street were shattered by shots fired at the negro and E. F. Dunlop, a negro who was in the same car, was hit by one of the bullets.
