houses, were generally laden with more coffee.

The flourishing town of Pescara is a mass of ruins from which there is already a sickening odor of dead bodies. More than 4,000 of the people of Pescara are reported to have been killed. Some of the corpses which have been recovered lie on the ground at street corners, while others are encased in coffins made of the first materials.

Through living persons are still being dug out of the ruins, there are only 120 soldiers at Pescara to assist the survivors in rescue work.

The town officials complain bitterly of the government's neglect. They say no bread has been obtained for the survivors, and the people and soldiers have had nothing to eat but vegetables brought from neighboring towns.

Pescara lost its most famous landmark, the sixteenth century castle of the Doria family, and the church where the famous Cardinal Mazarin was born.

The condition of the surviving population of San Benedetto, near Pescara, is deplorable. More than 4,000 of the 15,000 inhabitants of the town, 100 miles from Rome, have been buried in mass graves. They took out 1,000 bodies yesterday, and on Sunday and today they saved a young woman and a five-months-old child.

No survivors were recovered in San Benedetto until Sunday, although Pescara is only three miles away, although the town is still blocked by the sea.

Another severe earthquake was experienced at 6 o'clock Monday morning and the town, which had been quiet, was again in ruins.

Thousands of people were buried in the ruins of the town, and many buildings were destroyed.

Loss Recently at La Boisselle

PARIS, Jan. 19.—Show fell yesterday in Belgium, northern France and in the Yonne, but the French are still in those sections of line of battle, according to the official communication.





TWO STEAMERS REACH BREMEN WITH COTTON

H. M. Atkinson, Part Owner of One Ship, Confirms Reported Arrival

Positive evidence that cargoes of cotton from the United States are getting into European ports without serious interference by any of the belligerent powers is contained in an Associated Press dispatch from London which reads as follows:

LONDON, Jan. 19.—The Cottone Green, a British steamship which has been received here, announced that the steamers Denver and Gretna, both of which had been captured by the British, had been stopped by British warships but had arrived safely in Bremen and were due there.

This dispatch was confirmed in Atlanta Tuesday by H. M. Atkinson, who is a part owner of the steamship Gretna, which was captured by the British, and the chief stockholders of the Coast Steamship company, which owns and operates the Gretna and other vessels.

Mr. Atkinson states that the Gretna was sailed from New Orleans three weeks ago with 1,000 bales of cotton and made good time, considering the fact that her cargo was examined at sea by British warships.

Mr. Atkinson believes this vessel is the first to reach Bremen, a German port, since the war began.

He states that she will bring back a full return cargo and will sail again to Bremen with cotton.
