GERMANY GETS A FIRM WORD: U. S. PREPARES PROTEST TO BRITAIN

Ambassador Gerard Delivers American Note on Submarine Warfare to German Foreign Office Friday Morning

WILSON WILL PROTEST ATTACK ON THE ORDUÑA

New Protest to Great Britain Against Interference With U. S. Commerce to Be Sent During Next Week

(By Associated Press.)

WASHINGTON, July 23.—The American note regarding Germany's submarine warfare has been delivered to the German foreign office in Berlin by Ambassador Gerard.

The new note to Great Britain protesting their interference with the commerce between the United States and other neutral nations has been almost completely approved by President Wilson and Secretary Lansing with only a few minor changes to be made before it is dispatched to London early next week.

The United States will make further diplomatic representations to Germany, it was learned today. Inquiries regarding the submarine attack on the Cunard liner, Lusitania, at a time when she was bringing a score of Americans home, will be made at an early date.

Another American note to the German government, the bark Duesenreper, has been sent by German authorities and carried to the United States.

NOTE TO GERMANY.—With the delivery today by Ambassador Gerard to the German government of the new American note warning Germany that the loss of American lives through further violations of neutral rights would be regarded as "unfriendly" by the United States here it is for the present at least.

The note will be given over here for transmission to Berlin. The officials of the Washington government turned expectantly toward Berlin for some indication of the German attitude toward the note.

WASHINGTON, July 23.—Following the assassination of the Archduke Francis Ferdinand, heir to the throne of Austria-Hungary, and his wife, the duchess of Hohenberg on June 28 by a Serbian student, Austria sent a note to the Serbians ultimatum to Serbia, demanding that Serbia use every means in its power to punish the assassin and to stop all further anti-Austrian propaganda.

HOUSE PASSES BILL TO INCREASE PENSIONS OF CONFEDERATE VETERANS

ELOQUENT ADDRESSES RECALL DAYS OF WAR

WASHINGTON, July 23.—The house of representatives Friday morning unanimously passed a bill increasing the pensions of Confederate veterans, introduced by Representative Dart of Ohio, who is himself a veteran.

Several amendments were made in the measure. As adopted it provides that pensions beginning in 1916 shall be \$10 a year, in 1917, \$30 a year; in 1918, \$40 a year; in 1919, \$50 a year; and for every year thereafter, \$10 a year.

The bill was further amended to provide all totally blind pensioners with \$10 a year, beginning in 1916, and for every year thereafter.

Many members spoke for the bill, addresses brimming with eloquence and in many cases bringing tears to the eyes of the audience.

Representative Dart, the author of the bill, made a beautiful plea for its passage. Mr. Ayers of Ohio, spoke for the bill, declaring that his father was a veteran and that he himself was a veteran.

AGREEMENT IS REACHED IN STRIKE AT BRIDGEPORT

Work at Remington Arms Plant Probably Will Be Resumed Monday

(By Associated Press.) BRIDGEPORT, Conn., July 23.—With the arrival here today of Samuel Gompers and a number of executives of the International Union, J. J. Johnston, vice president of the Structural Iron Workers, announced that they had reached an agreement for settlement of the Bridgeport labor troubles had been signed. The terms of the agreement, he said, probably would be given out later today. It is announced work probably will be resumed Monday.

Mr. Johnston said it had been decided that the next move in the campaign for the settlement of the strike was to be made at the Winchester Repeating Arms company at New Haven, also engaged in the manufacture of war munitions for the allies. The Winchester company is building a big addition to its plant.

TEACHERS PAY BILL PASSED BY THE SENATE

Measure Creating Office of State Auditor Also Was Passed Thursday

The senate Thursday passed the bill by Senator Walker, of the Twentieth, providing for the more prompt payment of school teachers by a unanimous vote. It also passed by a vote of 75 to 6 the bill by Senator Adams, of the Thirtieth, creating the position of state auditor.

The state auditor's bill, while passed by a large majority, carried a number of amendments. The bill creates the position of state auditor, whose duty it shall be to audit all warrants against the state and to supervise the accounting in all state departments. The bill expressly provides that all bills or accounts against the state shall be audited by the auditor before they are sent to the governor and that officials have drawn warrants the warrants and the bills must pass through the auditor's hands to be again checked.

An amendment by Senator Boykin, which was adopted provides that the auditor shall have one assistant and one clerk instead of two clerks of out. An amendment by Senator Pickett, of the Eleventh, fixes the salaries of the auditor, his assistant and his clerk at \$2,400, \$1,800 and \$900 per annum, respectively.

An amendment by Senator Peacock, of the Fourteenth, provides that the auditor shall give a \$100 bond for the purpose of the bond to be borne by the state. The officials are to be appointed by the governor.

Practically the same bill lacked three hours of passing the house of representatives on Thursday and on Friday advice of reconsideration was given. The bill reached a majority on Friday, 95 votes, and received 92 votes and only 87 were cast against it. Friends of the measure declare that the bill will pass the house.

Although consideration of the state auditor's bill occupied the senate for nearly two days, it had no opposition and passed after only thirty minutes discussion.

The bill provides that the governor shall issue warrants for the salaries of the teachers monthly, in advance, and provides an arrangement with the banks, whereby the treasury warrant for the payment of a small rate of interest on the warrants, when there is no cash immediately available.

Senator Walker during the short discussion of the bill, asserted that under the system now in use that teachers have to discount the treasury warrants with their banks, paying in some instances as high as 5 per cent and in some instances as much as 8 per cent on the face value of the warrant.

With the state dealing with certain banks to handle the warrants the interest rate can be fixed at 4 or possibly 3 per cent, he said, making a considerable saving for the teachers in addition to making more prompt their receipt of their salary warrants.

Senator Ransome, a school teacher, expressed his approval of the bill.

Without acting upon the bill to appropriate \$18,000 for agricultural school America the senate adjourned until Monday morning at 11 o'clock.

RED-CROSS IS FORCED TO ABANDON MEXICO

Chaotic Conditions Compel Organization to Stop Relief Work

(By Associated Press.) WASHINGTON, July 23.—The Mexican situation again came to the forefront today with a conference between President Wilson and officials of the American Red Cross, who have virtually abandoned their campaign for the relief of non-combatants in the southern republic because of chaotic conditions there. The dispatch, from the State to Germany, caused officials to turn their attention to Mexican affairs, although no decisive move in that direction is contemplated at present.

The president's callers included Brigadier General C. A. Devol, general manager of the Red Cross who directed relief work in Mexico; Ernest Bicknell, national director, and Miss M. M. Boardman, a member of the central committee. General Devol was to report on the situation and his failure to get the various leaders to facilitate the work of feeding the starving civilian population. He was to tell the great deal that conditions are even worse than when he called on the leaders to settle their differences.

Officials and diplomats were surprised over the news that the general Carranza in serving notice that he would not receive communications from or transact business with foreign governments accredited to his government at Vera Cruz. It had been generally understood that foreign governments were awaiting action by the United States before recognizing any government in Mexico.

It was stated that Carranza's action would be to cut off the Carranza government from further communication with foreign nations having ministers resident in Mexico, although it would not, it is believed, sever his informal relations with the United States as he is said to regard Colonel Silliman at Vera Cruz as his temporary agent.

Vila governor prepares for last stand in Sonora

DOUGLAS, Ariz., July 23.—Jose Martinez, Vila governor of Sonora, is today hurriedly making his available forces in the state for a last stand at Nogales, against the Carranza troops which are marching every effort to capture Sonora. Advice received here state that estimates based on careful observation of the Carranza forces in Vila troops in the town at 1,500, but it is believed that the Carranza force is reinforced by 1,000 troops from Guzman.

The main army of General Calles, at last, was reported near Santa Cruz, where the advance guard is stationed.

PITTSBURGH, July 23.—A warning of a clear reflection of one of the most dangerous curves in western Pennsylvania, the Trencher Curve, near Meadville, has been placed at the top of the Town's Ferry bill by the New Kensington Automobile club here. 'INVISIBLE' PROPERTY TAX MEASURE VOTED DOWN

Senate Finance Committee Votes to Report Adversely on Persons' Bill

The vote of 8 to 3, the finance committee of the senate, of which Senator Akin, of the Fourth, is chairman, reported adversely Thursday afternoon on Senator Persons' bill to compel a return on money, money lenders or "loan sharks" that were not incorporated in Georgia, and other "invisible" property to county assessors.

The committee also killed an amendment to the bill introduced by Senator Persons aimed at meeting the objections of some of the opponents of the measure. The amendment exempted banks and other incorporated institutions engaged in money-lending from the registration provision of the bill, not exempting, however, money lenders or "loan sharks" that were not incorporated.

Senator Persons said the banks paid more taxes and made more complete returns than any other class of business individuals, but that he knew of "loan sharks" that did not admit to possessing up into the hundreds of thousands of dollars which never paid anything but a poll tax.

Senator Persons cited a Mason case as an example of the present tax equalization law, such tax dodgers could be discovered. But, he said, although the records kept of such loans and transactions in "invisible" property, yet it would require the services of attorneys at from \$10 to \$25 a day to hunt up these records for the use of the tax assessors. His bill, he said, was to provide a means of enforcement in fifteen lines of type that would cost the state over \$100,000—what it would cost to dig up records and enforce returns under the present tax law.

Senator Persons' bill as has been outlined before, provided that all bills, checks, notes, etc., must be returned and must bear the stamp of the tax assessors before such instruments could be sued upon in court.

The objections to this, as raised by Senator Akin, Senator Stovall, Senator Walker and others of the finance committee, were that it would allow the assessors to dig into and disclose intimate facts in regard to business which might prove ruinous to the credit of the business. In other words, as some of the opponents put it, many banks and business houses would have to close up their doors if their exact real credit and state of credit were disclosed to the public.

Senator Akin opposed the bill and the amendment very strongly, insisting that such a measure could not originate in the senate anyhow, as it was a tax measure and should begin in the house. For this reason, if for no other, he urged that the bill and the amendment be killed.

GEORGIA NOT AFFECTED BY NEW EXPRESS RATES

Increased rates on small packages which were allowed the express companies by the interstate commerce commission, will not apply to such traffic inside the state of Georgia, unless the railroad commission should grant the increase.

The interstate commerce commission's rule affects packages weighing less than five pounds, but it has no effect on any package shipped from one point to another in Georgia.

War Paper Printed During the Sixties Is Resurrected Today

They are calling for recruits and planting the white feather on young men in England today. Just fifty-three years ago they were paying \$50 bounty in Atlanta for every recruit. The Southern Confederacy, the only newspaper published here then, tells the story.

In a mouldy lane for Thursday, March 6, 1862, which has been resurrected by an Atlanta, the following advertisement appears at the top of the column two:

"One thousand volunteers wanted! Fifty dollars bounty will be paid to each soldier as soon as mustered into service! Fifty dollars per annum for clothing and \$11 per month as wages! Having received authority from the war department to raise a regiment for the west, we are now recruiting for the same in signed Colonel Jesse A. Glenn."

Below it are similar notices, signed by A. J. Vickers, Palmetto, Ga.; J. C. Morris, Conyers, Station, Ga.; Captain E. B. Henry, Bergant, J. St. Moore; Z. A. Rice, Captain Fulton, Dragoons, Cobb's Georgia Legion; William Wright, captain Barlow Avengers; many other well known Georgia names.

In the same issue General Robert Toombs gives his reasons for declining the Georgia senatorship in the Confederate congress. Lists of war subscribers like those now being taken for the Belgians are printed; advertisements of stores for sale appear; also advertisements for clubs for "clean" men for four and for sine sheeting.

"Uncle Jimmie" joined the Brotherhood July 1, 1890. Not long ago the grand lodge passed a resolution that twenty-five years' paid up membership should entitle the member to the veteran's emblem. "Uncle Jimmie" therefore became eligible July 1 of this year and the presentation was made by W. C. Puckett, of Atlanta.

COUNCIL VOTES TO CALL BOND ISSUE ELECTION

Each Item of \$3,258,500 Provided for Will Be Voted on Separately

The city council Thursday voted to call an election for an issue of bonds aggregating \$3,258,500 to care for the needed improvements in six of the municipal departments.

Council has divided the proposed issue as follows:

- Public schools, \$1,000,000.
- Sewers and disposal plants, \$1,000,000.
- Waterworks department, \$750,000.
- Grady hospital, \$375,000.
- Fire department, \$138,500.

The council resolution fixing the amount of the proposed issue instructed the city attorney to draw an ordinance calling the election, so arranging the ordinance that each item can be voted upon separately.

Council, which was in special session Thursday, took up each item separately and there was much discussion.

The longest and most heated wrangle was provoked by the Grady hospital issue, which provides \$750,000 for pay wards. Dr. J. C. White wished to reduce the amount of the Grady issue so that the pay wards could not be included. He asserted that the physicians of the city did not want a pay ward at the Grady and would fight and kill the issue if it was included.

When the charge was made that the city would be competing with private sanitariums, Alderman Albert Thomson, chairman of the bond committee, replied by stating that the city already has a monopoly on the sale of water, and that it is likely to enter into competition with the Georgia Railway and Power company by installing an electrical plant at the crematory.

The proposed water bonds will enable the city to purchase much new machinery, which is badly needed.

The appropriation for the fire department is for the purpose of providing motor equipment throughout the department.

The proposed sewer bonds, it is estimated, would enable the city to complete its trunk sewerage system.

A large portion of the \$1,000,000 provided for schools would go towards the proposed university high school, if it is likely that the election will be called within the next sixty days.

RIGHT TO FIX TAX RATE IS WANTED FOR ATLANTA

Alderman Armistead Introduces Ordinance Asking for Charter Amendment

The ordinance by Alderman Jesse W. Armistead to ask the general assembly for a charter amendment, which would give the city the right to fix its own tax rate was filed Thursday afternoon with the clerk of council, but not read, as council adjourned immediately after it considered the bond committee's report for which the special meeting was called.

Alderman Armistead states that he will make a fight for action on his ordinance at the next regular meeting of council. Mr. Armistead states that the calling of a bond election does not effect his ordinance.

CHANGE IN GEOGRAPHIES IS CAUSE OF PROTEST

Patrons of Schools May Ask Board to Let Present Books Stand

The action of the board of education Thursday in making an eleventh hour change of geographies in two grades has caused a storm of protest from parents of school children in all sections of the city.

The board will probably be asked to reconsider its action at its next meeting, which will be held before the first of the month. The board, by a vote of seven to three, selected the Tarr-McMurray geographies for the fifth and seventh grades, leaving the Frye geography in use in the fourth and sixth grades for the next year. The three members of the board who voted against the change, which will cost the parents of the children who are already supplied with the Frye books, hundreds of dollars, were: Chairman Gunn, James E. Key and A. P. Morgan.

For the change were W. H. Terrill, Jesse W. Armistead, George F. Eubanks, J. N. Pierce, Aldine Chambers, Harvey Hatcher and Dan Cates.

WARDLAW GETS PLACE.
The board Thursday afternoon elected J. C. Wardlaw, a member of the faculty of the State Normal school, at Athens to the position of assistant superintendent of schools, which carries a salary of \$3,000 per year and is one of the most important positions in the school department.

Mr. Wardlaw is a graduate of Emory college, having received both the A. B. and the A. M. degrees from that institution. He has also taken advanced courses at the University of Chicago. Mr. Wardlaw has been superintendent of schools at Dublin, Albany and Thomasville. He was for some time professor of pedagogy at the Georgia Normal and Industrial college at Milledgeville. For several years he has been at the State Normal and has also held a professorship at the summer school of the University of Georgia. He is president of the Georgia Teachers' association.

Mr. Wardlaw was present at the meeting of the board and accepted the position.

After the election of an assistant superintendent the board named the following new teachers: Mamee Carlotta Alexander, Lucile Youngblood, Nell McFall, Ann Kleinaechter and Marion Morris.

Miss Morris will teach science in the Girls' High school. Miss Georgia Crans was elected a supernumerary.

APPEAL FOR TEACHER.
Action upon an appeal from the Home for the Friendless to assign one of the school teachers to the institution, was deferred.

The board adopted a resolution by which it will be jointly controlled by the present medical department of the schools and organized a new department which will be jointly controlled by the city health department and the board. Mr. Chambers expects his resolution will save the city \$1,000 a year and to improve the efficiency of the department.

The Chambers' resolution provides for one chief medical inspector to devote all of his time to the work. He will receive \$1,000 per year. For stated periods during the year he can employ assistants, not to exceed three in number at salaries of not exceeding \$300 a year. There shall be five nurses in the department to work for six days in the week instead of five days, visiting the homes of the children, when school is not in session. The medical arrangement for the negro schools was not changed.

LANDRUM'S STATEMENT.
Superintendent L. M. Landrum Friday morning gave out a statement on the cost involved in the exchange of the geographies.

"The change applies," said Mr. Landrum, "only to two grades, the fourth and the sixth. The children of the fifth and seventh grades, who have had a year with Frye geographies, will continue with them. The elementary Tarr-

McMurray books for the fourth grade can be purchased for 55 cents each. If he has an old primary Frye he can exchange it at the book store for a new Tarr-McMurray by the payment of 35 cents.

"In the sixth grade the cash price of the Tarr-McMurray is \$1. Where a child has purchased an advanced Frye since June and has not used the book he can return it and secure the Tarr-McMurray on the payment of 12 cents, the unused Frye being received at its purchase price of 35 cents. He can exchange an old advanced Frye for a Tarr-McMurray on the payment of 65 cents, and he can exchange an old primary Frye for the advanced Tarr-McMurray on the payment of 45 cents."

U. S. WILL NOT ALLOW EXTRADITION OF GERMANS
Those Who Work in Ammunition Factories Need Not Fear Prosecution

(By Associated Press.)
WASHINGTON, July 23.—State department officials said today that Germans in the United States, who might be prosecuted, as was announced from Berlin last night, for working in ammunition factories in lands supplying war materials to Germany's enemies, were in no danger of extradition and would not come under the effects of the German law while they remain in the United States.

Should such Germans become naturalized Americans in the meantime and return to Germany at the close of the war they are protected by the naturalization treaty under which the United States could intervene in their behalf.

JAS. M. SULLIVAN QUILTS HIS DIPLOMATIC POST

Minister to Dominican Republic Was Held Unfit for the Office

(By Associated Press.)
WASHINGTON, July 22.—James M. Sullivan, American minister to the Dominican republic, has tendered his resignation to President Wilson and it has been accepted.

Mr. Sullivan's resignation is the consequence of an investigation, conducted for the state department by Senator Phelan, of California, into the minister's fitness for his office. The findings were unfavorable to Mr. Sullivan.

Senator Phelan's report has been at the state department and before President Wilson several weeks. Soon after it was received it became known he had been asked to resign, and had been given a short time to consider it.



A YEAR AGO TODAY
AUSTRIA TOUCHED
OFF SPARK OF WAR

(Continued from Page One.)
while the Austrian army of invasion was crushed near the Drina river.
On September 23 the world was astounded when the German submarine U-9 sunk three British cruisers in the North sea.
Canada contingent of 32,000 troops was sent to England on September 24.
The siege of Antwerp was begun on September 28 and by October 8 the city had fallen. Meantime the Russians had swept through Poland in a drive for Posen and the Japanese bombardment of Kiaochow had started. The Japanese were busy seizing German island possessions in the eastern Pacific.
The Belgian government moved again on October 11, this time to Havre, France, and the allies gathered over into Belgium. In Poland the great battle of the Vistula was begun within 30 miles of Warsaw.

OSTEND IS TAKEN
BY GERMAN FORCES.
Between October 15 and 25 the Germans took Ostend, the first battle of Ypres had begun, and the Russians were winning in Poland. The U-9 had also been heard from again, sinking the British cruiser Blawke on October 16. On October 17 the British cruiser Audacious was torpedoed.
Meanwhile a rebellion had been started in South Africa on October 25, by General de Wet and General Beyers.

The bombardment of the Dardanelles by an Anglo-French fleet began November 2. On November 4 Turkey broke with the allies. On November 5 England and France declared war on Turkey, while Russian troops invaded Turkish territory.
Meantime a German squadron had bombarded the British coast near Yarmouth, while the German western Galicia the Russians were winning steadily, having retaken Jaroslavl.

In the east, Tsingtao, the Japanese stronghold, fell before the Germans on November 6. In France the Germans made desperate efforts to cross the Yser and Dixmude. On November 11 the Russians were able to swing in on Premysl again and invest the city. In Egypt, the Turks were having some small successes.

November 17 the floods in Belgium having increased, the first battle of Ypres was ended, while the Germans checked. In Poland, the Russian troops were falling back and losing thousands of prisoners to the Germans, while the Austrians were victorious at Ypres.
November drew to a close with the Germans attacking the British with difficulty from a Russian trap near Thorn, while the Russians were forcing a campaign into Hungary over the Carpathians which later ended in disaster. In the west the French were reporting gains all along the line, British warships having captured the German naval base at Zebrugga.

On the last day of November the Austrians captured Belgrade, Serbian capital, after 125 days' siege.
BRITISH FIRE TORPEDOES
A British squadron surprised a German squadron in the South Atlantic on December 8 and sank three of the enemy's ships with a loss of 3,000 lives.
By December 14 the Serbians recaptured Belgrade, after routing three Austrian army corps. The Italians were driven back to the San. Three towns on the eastern coast were bombarded by German warships on December 17 and the same day England declared a protectorate over Egypt.

The last part of December was marked by night Russian advances in Hungary and northern Poland but the Germans gained somewhat by victories in East Prussia, on Christmas day. The same day British warships raided the German harbor of Cuxhaven in the North sea.
On January 1, 1915, the Russians were driven back over the Polish border and the British warship Formidable was torpedoed in the Thames.

The close of January brought a new Russian advance in East Prussia with 80,000 men while on the western line each side gained and lost alternate gains.
February 5 Germany warned all vessels away from war zone around Great Britain after February 18.
On February 6 the Lusitania, to evade German submarines, flew the United States flag by order of the British admiralty. This was followed by February 10, when the United States to Germany against its decree of marine war zone and to England against the use of neutral flags by British ships.

February 12 the czar's forces were driven from East Prussia with a loss of 50,000 prisoners, while the middle of the month was marked by several British air raids on the Belgian coast.
On February 18 Germany's famous marine "war zone" order was put into effect.
The month of February was rounded out by her big German victories in East Prussia. Great Britain's reply to the flag note denying any intention of the general use of neutral flags.

NEUVE CHAPELLE
BATTLE IS FOUGHT.
In the western front the early part of March brought a British victory at Neuve Chapelle, a terrible setting, while in the east the Russians captured big Austrian forts near Tarnopol and Poles. March 14 the German cruiser was sunk by three British warships off Juan Fernandez island.
The British battleships Irresistible and Ocean and the cruiser Aboukir were sunk by mines in the Dardanelles on March 18, while the British battleships and the French Gaulois were disabled.
With the opening of the spring campaign the French forces on April 3 began a series of hot attacks on the German lines between Verdun and Metz. In the Dardanelles the allied fleets had temporarily withdrawn. In the Carpathians the Russians continued to be successful.
During the middle of April a fierce struggle for possession of Hill 60 near Ypres went on, with the Germans making some gains by use of gas bombs.
On April 19 Field Marshal von Hindenburg took command of the Austro-German forces to conduct fresh campaigns against the Russians, who had advanced severely in the Carpathian passes.
In the Dardanelles the allied fleets resumed the bombardment of the forts along the straits on April 22. On the last day of the month the German ambassador warned Americans by a newspaper advertisement to avoid entering the "war zone" on ships of the allies. The next day the American oil ship Grifone was torpedoed without warning and the

with controlling buttons on which the receiver of the ordinary phone is clamped down. The words spoken into the telephone from both ends are transferred to the Telescribe and thence to the dictating machine where a blank wax record catches every one.
The Telescribe can be attached at a moment's notice to a telephone and released in a second. It has been tested from San Francisco to Orange, N. J., and the resulting record was a good one.
The effect of the Telescribe will have manifold. With it attached any telephone conversation can be preserved as long as the record lasts. In discussing a business deal over the phone with another party the business man simply has to attach the Telescribe, get the words recorded and then turn the record over to a stenographer to fill the order. Criticisms for supposed personal errors in receiving or transmitting telephone orders or doubt as to correct quotations will be done away with.
When a man declares, "But I didn't tell you that over the telephone," just pull the record on him. He may not even know that it was attached when he talked to you, but the Telescribe settles the argument.

The U-51 gained fame by making the long trip from German base at Wilhelmshaven to Dardanelles.

GOVERNOR HARRIS NAMES PART OF MILITARY STAFF

General J. Van Holt Nash Re-appointed Adjutant General and Chief of Staff

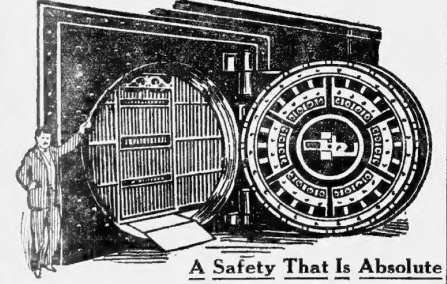

UNIDENTIFIED MAN IS KILLED IN INMAN YARDS

Initials "R. E. V." Marked in Collar Is Only Clue to Identity

The initials "R. E. V." are the only clue to the identity of a man who was killed early Friday morning by an outgoing freight train at the western end of Inman Yards. The body was removed to M. M. Patterson's undertaking establishment, where a coroner's inquest was held later in the day. So far no one has been found who knew the dead man.

There were no eye-witnesses to the accident, it is said, trainmen picking up the body a moment after it had been almost severed at the waist line by the engine wheels.

The man was well dressed in a dark suit, with a pair of overalls worn over the trousers. He wore a collar and tie and carried a gold watch. There were no papers in his pockets, only a bunch of keys. The initials were printed on the inside of his collar. He is about five feet five inches tall, thirty years old, with a gold tooth on the right side of his jaw.

WALTER DENNIS BREAKS RECORD FOR SETTING TYPE

Atlanta Boy, With Intertype Machine, Sets 14,700 Ems of Six Point in One Hour

News has reached Atlanta that the world speed record for intertype composition has been broken by Walter N. Dennis, an old Atlanta boy and formerly an operator on The Journal.

Mr. Dennis has many Atlanta friends and several relatives living here. He was the husband of Lois Beltra Dennis, whose disappearance two years ago with her sister, Beatrice Nelson, resulted in a nationwide but fruitless search.

Advices from New York state that Mr. Dennis is a test witness by manufacturers of the intertype machine, set in one hour 14,700 ems of solid six point, which is equivalent to about 240 words a minute. The intertype is similar to the linotype machine.

PANAMA CANAL IS NOW ALMOST SUPPORTING SELF

Leaving Off Interest on Cost of Construction, It Is Making 5 Per Cent

(By Associated Press.) WASHINGTON, July 23.—Counting only the cost of operation of civil government, sanitary work and administration and the handling of ships, the Panama canal is now on a paying basis, according to official reports.

Receipts for 1914 not only wiped out the deficit of \$28,486, which had grown up since the opening up of the canal trade, but left a balance of \$177,799, which works out a profit of 4.79 per cent on the expenditure.

This, however, does not make any allowance for interest on the vast sum of money expended in the construction of the canal and from that point of view the receipts from tolls have not yet equalled the expenses.

COLUMBUS OPPOSES CHANGES IN SCHEDULES

COLUMBUS, Ga., July 23.—Columbus business interests are lining up almost solid against the proposed change in schedule on the Southern railway between Columbus and Atlanta, which, if made, will make the Atlanta mail matter an hour later coming in and will prevent the answering of all western mail on the same day it arrives because of the early departure of the outgoing train.

Petitions are being circulated and freely signed today by members of the chamber of commerce, urging the railroad commission to disallow the change. These petitions will be taken before the commission at the hearing, which is set for July 27, by a committee of citizens representing the chamber of commerce, which will be joined in Atlanta by Representative Cecil Nell, and a strong fight will be made to prevent the change.

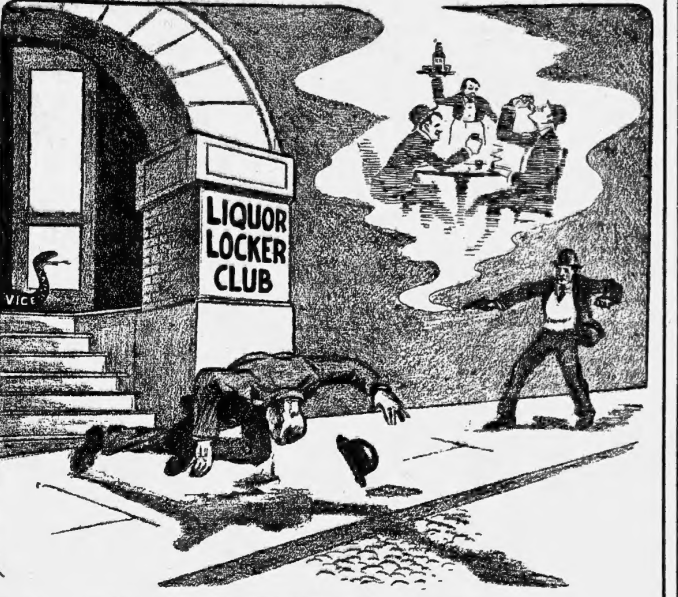

At its door, a man shot to death a man with whom he had been drinking within.

They licensed the Eagles. In the basement of the building, where they roost, a man was found dead beside a whisky flask. Another, who had drank there, was shot down before the door of Carnegie Library by his companion.

The Mayor and Council licensed the Druid Hills Club. There, the bartender killed a waiter in a dispute over an order for drinks.

IF the Mayor and Council had refused to license these clubs, would not these dead men be alive today? Think for yourself!

Each killing has cost Atlanta, Fulton County and Georgia, many times the license fees paid by these clubs. Murder trials are costly. And when the killer goes unpunished the cost cannot be computed in dollars and cents.

YOU must figure in the value of the life of the next man to be slain by those taught to believe that law means nothing.

You must appraise the suffering of his loved ones. Then, look at this—

In spite of facts and protests, Mayor and Council have again licensed club after club, each one of which has broken the law.

In the last two weeks the Police have pulled five clubs. Last Monday Council licensed again the Owls, the Terrace, the Greek and the University Clubs.

Some here seem bent on Beckerizing the Police Force. Clubs are being licensed in the face of their own written statements showing thousands of dollars made in the liquor traffic.

Clubs claiming to be reputable are cloaking those notoriously organized to do a liquor business.

WE APPEAL—SENATORS AND REPRESENTATIVES, repeal those laws which furnish the excuse for this disgrace!

If the rising tide of lawlessness is not stopped in the cities of the state, every county, every crossroads, every village, will have the blind-tiger masked as a locker club!

We ask YOU to end this shame before it is too late. We attack no man. We have made no fight on any member of this house. We wish to fight none.

NOR do we impugn the motives of MESSRS. EAKES, FULLBRIGHT and SPEAKER BURWELL.

But we are forced to say that the bills known as the **EAKES-FULLBRIGHT SUBSTITUTES**, favorably reported by the Senate Committee on Temperance, and now before the Temperance Committee of the House, leave untouched the near-beer and locker-club laws.

COUNTY COMMISSIONERS SLEEP IN CONVICT CAMP

New Fulton Honor Camp Said to Be Finest in State

Convinced that the new Fulton county honor convict camp on the Sandy Springs road was the finest and most comfortable in the state despite the opposition of Marion Jackson and Philip Weitzer to the proposed camp "cages" four months ago, four Fulton county commissioners, accompanied by thirteen other county officials motored out to the camp Thursday afternoon and slept there Thursday night.
 "Just like sleeping in a Pullman car," said Commissioner S. B. Turman, chairman.
 "I thought I'd wake up in Savannah or Macon—but the cars didn't move, after all," said Commissioner Tom Winn. Oscar Mills sat on the cotton mattress on the springs of a lower berth and bounced up and down. His head didn't hit the upper berth.
 "That shows the convicts will have more comfort than in a sleeping car," said Mr. Mills. "You couldn't do that in a car without hitting your head on the top berth."
 Dr. W. L. Gilbert, the fourth commissioner present, agreed that the camp was the best in the state.
 The party had a delightful time. In front of the camp was the kitchen, stretched under a fly-tent, under which stood also the dining table.
 To the left of the kitchen stood the camp proper. Here, under two immense eyes of canvas, stood the three portable camps of "cages"—the same "cages" that were so vigorously opposed but which the commissioners used as their best camp, maintaining that no convicts elsewhere in the south could be more comfortable than those who would live in these "cages."
 In each of the portable camps (for the "cages" are on wheels, and can be rolled to any part of the county as the work demands) are twelve berths—six lower and six upper. These berths have comfortable springs, cotton mattresses, sheets, pillows and blankets, with plenty of head room. Down the center of the cages extends a carpeted aisle, to the right and left of which are toilet compartments, equipped with open plumbing and running water.
 Behind the three portable camps is the pumping station, attached to a well, and back of that is the corral for mules. These in the part were, besides the four commissioners already named, Warden Charles H. Girardeau, Tom Wilson, county engineer; William A. Hansell, Jr., superintendent of public works; C. M. Holland, purchasing agent; police; Frank Eaves, construction superintendent; Oscar Jones, assistant superintendent of public works; James L. Girardeau, deputy clerk of the municipal court; the county auto driver, C. W. Smith, the public works office; Burge Greene, deputy warden; Robert Wright, chief of the honor ward man; and Journal reporter and photographer, J. J. Hightower, Jr.
 Commissioners T. J. Hightower, Jr., W. N. Egan were invited to accompany the party, but previous engagements kept them away.
