"Deliberately Unfriendly" Is

**TWO AMERICANS ARE
REPORTED AS MISSING**

Washington Awaits Official
Report as to Whether Arabic
Was Warned Before Ship
Was Attacked

QUEENSBURG, Aug. 20.—Mrs. Josephine Bruguliers and Dr. Edmund F. Wood are the two American passengers on the Arabic definitely ascertained to have been on board the ship which was the last seen of the bodies of the disaster, searching for the bodies.

WASHINGTON, Aug. 20.—The official details upon which President Wilson has based his statement that the White Star liner Arabic was an act deliberately unfriendly to the United States, are not in accord with the statements meanwhile the president and other officials, while realizing fully the gravity of the situation between the United States and Germany, were keeping their minds open.

President Wilson left the White House early to motor to Philadelphia to meet the members of the cabinet. The problem in his mind it is the president's habit to seek seclusion, often riding through the streets in a motor car.

regard as "deliberately unfriendly") any act in violation of the rights of American citizens upon the high seas. The United States has consistently stated specifically that the lives of non-combatants are to be spared, and that piracy unless the vessel resists is not to be resorted to. The United States seeks to escape after being summoned to appear before the court.

If there was no loss of American lives it was regarded here as unlikely that the United States would have taken any action against the vessel. If there was it was believed that diplomatic relations between the United States and Germany would be broken off.

The attack on the Arabic caused general surprise here particularly in view of the fact that no hint had come from the United States that the United States commander would continue torpedoing ships without warning and despite the fact that the United States had stated here that in the future warning would be given. Officials here had hoped, therefore, that the United States and Germany would not be further aggravated.

Other officials here stated that they had received and they merely transmitted the reports of the White Star Line.

Am Ambassador Force forwarded a White Star liner to the coast of Africa, and was detained without warning and Vice Consul Thompson at Queenstown made a simultaneous arrest of the vessel and its crew. Mrs. Josephine S. Bruguiere, nee Dr. Edmund Woods, the two Americans still in the vessel.

Whether the captain, by leaving the steamer Dunley, which had just been damaged, was not guilty of dereliction of duty.

Whether the captain introduced any qualifying circumstances by violating the rules of the law of war.

Whether the captain was justified in attempting to risk itself by attempting to assist another which has been torpedoed.

Whether the Arabic was not a bona fide passenger ship, and whether the Arabic to succor those on another torpedoed ship was justified and was not a bona fide passenger ship.

Letter From Frank Reaches Brooklyn After His Death

Tells Aged Mother of His First Meal With Wife Since He Was Attacked by Prisoner

(By Associated Press.)
NEW YORK, Aug. 20.—Frank's mother today made public the last letter she received from her son. The letter reached Brooklyn yesterday having been written on the night of August 15, the evening before Frank was lynched. He wrote:

"I am sitting up in a rocking chair as I write this. I am very much stronger. At dinner today I sat to table with my dear Lucille."

"I have been sitting in a chair for an hour or so each day for the past few days. I am gradually learning to walk after the long stay in bed."

Frank added that his wound was healing rapidly and he was able to move his head pretty well. He concluded:

"Give my regards to all enquiring friends. With much love to you and all, in which Lucille joins me."

Mrs. Frank in her talk with reporters today, was asked if she forgave the men who lynched her son.

Do not ask me whether I forgive the murderers of my son," said Mrs. Frank. "Perhaps some day I will be able to answer that. Just now I can only quote Leo's favorite passage from the Scriptures. It was:

"Father, forgive them, for they know not what they do."

"I might add," but they will some time."

Dr. Adler Declares Georgia Alone Should Seek Lynchers

NEW YORK, Aug. 20.—Prominent Christians and Jews met here today to discuss plans for aiding Georgia to apprehend the men who lynched Leo M. Frank.

Isadora M. Levy, member of the board of education, who is interested in the movement, said a temporary organization had been effected and within a few days a strong appeal probably would be made to Governor Harris.

Dr. Cyrus Adler, chairman of the American Jewish committee, said he declined to work with the committee and did not believe his committee would aid in the matter. He said he thought the hunt for Frank's slayers was a matter for Georgia authorities.

NEGRO MAIL CLERK IS HELD ON THEFT CHARGE

Big Collection of Stolen Articles Found in Home, Say Inspectors

In the office of Postoffice Inspector R. E. Barry at the federal building is a collection of stolen articles ranging from a Swiss watch to a side comb, which the inspectors found in the home of C. B. Florence, a negro mail clerk, who is under arrest.

Florence lives in Albany, and his run is on the Atlantic Coast Line between Albany and Thomasville. He admitted taking most of the goods, and inspectors said his operations had covered about two years.

His arrest at Albany followed his attempt to sell a box of cigars which the inspectors say he stole.

The total value of the goods taken by Florence is estimated at \$700, and consists of articles taken from the parcel post. In the collection is a large lot of silverware, most of it engraved; three watches; a diamond ring; an assortment of silks and linen goods, some made up into expensive garments and others in bolts; a hand bag, and the like.

Inspectors say that Florence gave most of the women's clothes to his wife, who was said to be the best dressed woman in Albany's darkened society. Among the booty are several expensive evening dresses. Most of the goods will be returned to their owners.

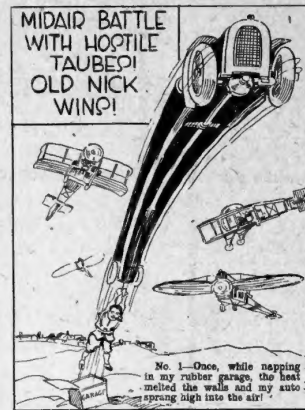

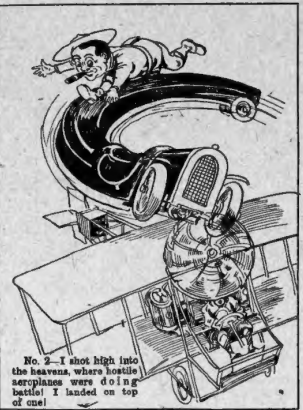

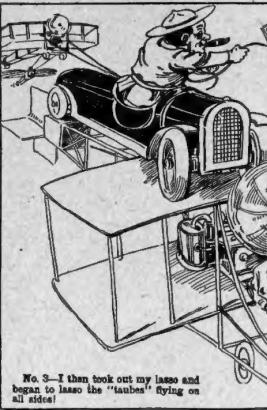

SCHOOL FOR WIVES RUN BY FORMER HELEN GOULD

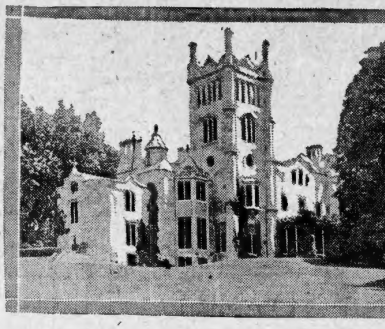

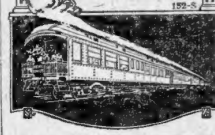

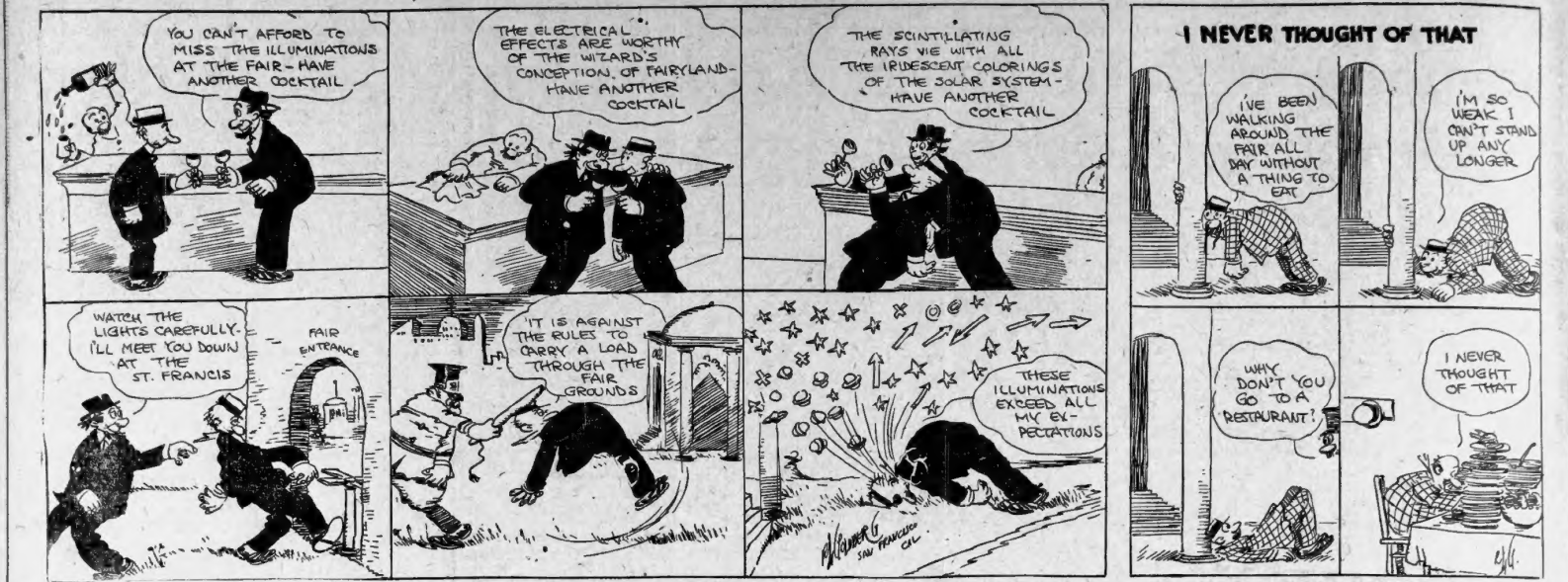

passengers aboard the Arabic. Sixteen have been accounted for here thus far. Captain Finch gave the Associated Press a detailed account of the loss of the liner.

"We were forty-seven miles south of Galley Head at 9:15 o'clock this morning," he said, "when I perceived the steamer Dunsley in difficulty. Going towards her I observed a torpedo coming for my ship, but could not discern a submarine. The torpedo struck one hundred feet from the stern making terrible havoc of the hull. The vessel began to settle immediately and sank in about eight minutes.

"My order from the bridge about getting the boats launched was promptly obeyed. Two boats capsized. We had taken every precaution while in the danger zone. There were plenty of life boats

on decks and the boats were ready for immediate launching. The officers and crew all behaved excellently and did everything possible in the circumstances, getting people into the boats and picking up those in the sea.

"I was the last to leave, taking the plunge into the sea as the ship was going down. After being in the water some time I got aboard a raft to which I also assisted two men and women."

Captain Finch paid special tribute to the heroic conduct of several engineers and firemen who remained at their posts to the last and sacrificed their lives to execute orders from the bridge, thus insuring the safety of the passengers. Among those lost was the captain's nephew.

"If I had been given a little more time by the submarine," he said ruefully, "I am satisfied I could have saved everybody."

Germany Treats U. S. Warning With Contempt; Says London

(By Associated Press.)

LONDON, Aug. 20.—The newspapers

comment at length on the effect the sinking of the steamer Arabic is likely to have on German-American relations. "It remains to be seen," says the Morning Telegraph, "what the civilized world will do—particularly the people of the United States, if it be proven that an American citizen has been killed. The American government already has stated its standpoint in the plainest language. Germany has treated the American statements with contempt."

The Times says: "The fact that the Arabic was outward-bound wipes away the whole web of falsehood and sophistry with which Germany sought to darken the case in its impudent and mendacious reply to the American note on the Lusitania. There can be no pretence that the Arabic was carrying armament."

The Daily Mail says: "Americans have been wondering why no reply has yet been returned to the note they sent Germany on July 21. The reply was given yesterday and deeds speak louder than words. There can be no doubt now as to Germany's determination to persevere in her piratical course with complete indifference as to whether any American citizen is aboard ships attacked."

The Standard says: "It would seem that President Wilson can hardly ignore this cool defiance of his recent note."

The desperate resistance of the Russians was broken at many points and they were forced to retire to prepared defenses in the immediate vicinity of the fortress.

An Austro-Hungarian army corps was pushed across the Big east of Dobrynka. Archduke Joseph Ferdinand's troops advanced from Janow and narrowed the circle. Northwest of Brest-Litovsk the Germans forced a passage across the Bug at several points.

The Russian retreat from Poland is reported to be attended by unprecedented and indescribable misery among the civil population. German officers returning to headquarters report thousands upon thousands of Poles returning in utter want to destroyed villages.

Thousands of war-torn and refugees block the roads from the Vistula to the Bug, mothers with children vainly seeking food.

Reports from the governments of Bessarabia, Klonow, Podolia and South Volynia indicate that the Russians are planning to evacuate this territory soon.

Harvesting and threshing are going ahead feverishly but no efforts are being made to plant winter crops.

For wishes to see a break between the United States and Great Britain. There may be more in his method than surface indications show. To say the least, he has obtained publicity, and both the British government and President Wilson are aware of the cotton situation.

"This may lead to an even more liberal treatment of the cotton collateral by the federal reserve banks, and it may possibly induce Great Britain to offer some scheme by which the surplus cotton, or a portion of it, may be paid for and held by Great Britain."

"Personally, I believe that if Great Britain purchased two million bales this year and stored it for a year or two years it would increase in value from 10 to 15 per cent in the year or two years."

Senator Smith has certainly, as we say in the south 'holled out loud' and his legislation may bring about an amelioration of the cotton contraband situation.

"But, as I have said, I do not see that Great Britain's action in making cotton contraband will depress the cotton market. I see ahead less cotton and higher prices."
